- 1. That the school shall abide by the provisions of Delhi School Education Act. 1973 and Rules framed there under as well as the instructions issued from time to time be the Depart ment
- 2. That the school shall admit students without any discrimination of caste and creed.
- 3. That the school shall meet the additional liability of secondary classes alongwith additional class rooms for class IX and X.
- 4. That the school shall purchase adequate science lab equipment and apparatus as per the norms of CBSE Educaion Department for secondary classess.
- That a proper library shall be established and facilities for reading room shall also be made available for students as well as for teachers. Books are as per the ratio of ten books per student shall be purchased and made available to the students.
  - 6. That the adequate sports material shall be purchased and made available to the students.
  - 7. That the school shall strictly abide by the provisions of section 10 (1) (A) of the Delhi School Education Act Rules 1973.
  - 8. That the school shall not run any unrecognized class or any non-educational activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately, if any.
- That the school shall dispense with the services of unqualified and over-aged staff, if any immediately.
- Fresh Health certificate from the MCD be obtained and produced to Education Officer for verficaion.

The Management of school will obtain land from DDA, if already not obtained, in the name of the Society through Director of Education, Delhi and shall construct the school thereon the school as per specifications of the Department within a period of two years. That ad equate and sufficient accommodation of 10 sq.ft. per student shall be provided the class from and shall be not less than 300sq.ft. area.

That the Managing Committee of school shall not increase/enhance fee during the ensure academic session without prior approval of the Director of Education which is mandator 13. requirement under subsection(3) of section 17 of Delhi School Education Act & Rules,

That the school authority will apply for P.F. facilities to the provident fund Commissioner - 14.

and will provide the same to the staff improper manner.

That all the facilities proscribed under Rule 50 & 51 of the Delhi School Education Rules, 15. 1973 shall be made available to the students.

That XIth class should not be added without the prior approval of the Directorate of Educt 16.

That the Management of the school shall create reserve fund equal to the minimum of Rs. 2 Lacs plus Rs. 80/- per student in the Joint name of the Dy. Director of Education and the 17. Manager of school.

That the school shall comply with the norms of the CBSE for affiliation for examination 18.

The school will apply for nominee of DE/Advisory Board to the Act Branch of Dte. of 19. Education.

The school should provide P.F., LTC Medical facilities to the staff as per DSER. 20.

That the report about the fulfillments of the above conditions shall be sent to the Education 21. Officer within Six month.
